#### NON-IMMIGRANT VISAS

Before applying for a non-immigrant visa (NIV), consider carefully whether you are qualified for the visa you intend to apply for. Nonimmigrant visas are for **temporary stays** in the United States and <u>are not for refugees</u>. There are no nonimmigrant visas for refugees. <u>If you apply for a nonimmigrant visa but do not intend to leave the United States, your application will be refused</u>.

ALL VISA FEES ARE NON-REFUNDABLE, regardless of outcome. The US visa application fees paid in Ukraine cannot be used for a visa application in Austria or any other country. You must pay the visa application fee in the country where you intent to apply.

If you are not qualified for a nonimmigrant visa, you may wish to refer to the humanitarian assistance information below.

#### **REFUGEE, ASYLUM AND HUMANITARIAN PAROLE**

The U.S. Embassy in Vienna does not process applications for U.S. refugees.

- There are no visas for refugees for travel to the United States.
- You cannot claim Asylum from outside the United States.

#### **U.S. IMMIGRANT VISA INFORMATION**

Immigrant Visa (IV) cases that were already approved and pending with U.S. Embassy Kyiv have been automatically transferred to the U.S. Consulate General in Frankfurt, Germany – the primary consulate handing all Kyiv IV cases. Please email <u>FrankfurtVisaInquiries@state.gov</u>, and use subject line: "C22 - UKRAINE – FULL NAME".

If both the petitioner and applicant(s) are physically present in AUSTRIA please contact <u>ConsulateVienna@state.gov</u> to discuss your options.

# If you are a U.S. citizen with a Ukrainian fiancée/fiancé in AUSTRIA seeking to travel to the United States on a K1 visa:

You *must have* an approved I-129F from United States Citizenship and Immigration Services (USCIS) before applying for a K-1 visa at a U.S. embassy or consulate abroad. If you filed an I-129F petition with USCIS that has not yet been approved, you can request an expedite for USCIS processing at <u>https://www.uscis.gov/forms/filing-guidance/how-to-make-an-expedite-request</u>. U.S. consulates and embassies are not authorized to accept locally filed I-129F petitions.

## If you are a U.S. citizen seeking to file an I-130 on behalf of your IMMEDIATE FAMILY ONLY (spouse, children, or parents):

If you have not yet filed an I-130 petition but wish to do so, you may contact U.S. Consulate General Frankfurt at <u>frnuscisinquiries@state.gov</u> to request local filing in Frankfurt. Please note that Frankfurt is only accepting I-130 petitions *filed by* **U.S. citizens on behalf of their spouse, child(ren) (under age 21) or parent(s)**. Both the petitioner and the applicant(s) must be physically present in Germany. In extremely urgent circumstances, U.S. Consular Section Vienna will consider accepting local filing. Contact <u>ConsulateVienna@state.gov</u> to discuss your case.

**IMPORTANT NOTE:** IV cases can take 1 - 2 weeks or longer to process. Applicants must be prepared to financially support their stay while in Vienna, including all required visa fees, mandatory medical exam fees, lodging and transportation costs, etc. **The Embassy does NOT provide financial assistance to IV applicants.**
